### **GM Report**

- GM Damian Tody reviewed the Operations Report and financials.
- Area labor shortages have caused some hiring challenges. A new hire has recently been made for a graphics/marketing person who will also work in various departments as needed.
- Sunflower Kitchen, the café collaboration with Okalahawa Brewery is finalizing equipment purchases and staffing positions. The Board will defer a tour of the operation to a later date.
- Blue Ridge Community College Café update labor shortages causing hiring challenges. This may improve after the school year ends and when the federal unemployment subsidy ends.
